Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the

state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

6. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

7. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Important Information to abide by the bidder

- 1. The Agency must have experience of handling the work in reputed organization including Govt. & Public S ector for at least 03 years. A certificate of satisfactory performance from such clients is also to be submitt ed.
- 2. Project Experience: The bidder must have executed at least 1 single order of 80% value of the Bid or 2 or ders each of 50% value of the Bid or 3 orders each of 40% value of the bid for similar service(s) in last thre e years to any Central / State Govt. Organization / PSU / Public Listed Company. Copies of completion certi

ficate is also to be submitted.

- 3. The Agency must be registered with the following statutory authorities and also to furnish attested copies of the documents:
 - a) ESI, EPF, GST & PAN
 - b) Income Tax return and Service Tax
 - c) Contract Labour (R&A) Act, 1970
- 4. The Agency must be registered and to submit valid registration under Private Security Agency Act of the Consignee state.
- 5. Copies of Audited Balance Sheet along with ITR for the last three financial years **2021-22**, **2022-23**, **202 3-24**.
- 6. The Agency must have Office in Guwahati. Proof like GST certificate, Labour licence etc. to be attached.
- 7. All above document should be authenticate in each page with seal and sign by Authorised Signatory.
- 8. Dispute, if any, is subject to Guwahati Jurisdiction only.
- 9. Successful bidder shall obtain Life Insurance Policy in favor of all Security Guard engaged for ESIC, North East Region (NER) for the contract period. The maximum monthly premium amount may be limited to the amount at A.2 + A.7. The amount of premium paid by the agency will be proportionately reimbursed on m onthly basis subject to production of premium payment receipt.
- 10. Security Guards to be engaged by the agency should not attain 60 years of age during the contract period
- 11. Proper field supervision has to be undertaken by the agency/successful bidder.

Scope of Work

- 1. The Security Guards should be made conversant with the layout of the building, all the entry / exit points, fire safety system along with all telephone numbers of the office / officers along with the telephone numbers of the nearest Police Station, Fire Station, Hospital, Estate etc.
- 2. Senior Security Guard / Security Supervisor to submit day to day report of happenings in the premises to the caretaker and suggestions for the strengthening of overall Security.
- 3. To follow the instructions of the Administrative Authority of the ESIC.
- 4. The entry / exit of the visitors to be properly attended and they may be guided after n ecessary Security Check.
- 5. Entry / parking of unauthorized vehicles should be monitored and banned strictly and they should not exhibit any rude behavior to anybody.
- 6. All office records / equipment or machinery may be allowed to be taken out of the building on ly with proper gate pass under signature by the competent authority.
- 7. The Security Guard should ensure to minimize wastage of electricity, water and other resource s by taking round of the building on 24 hrs basis and overall responsibility of Security guards is t o safeguard property, life and to help in maintaining peaceful office environment.
- 8. The Security Personnel must ensure that there are no unidentified / unclaimed / suspicious objects / persons / vehicles in the premises.
- 9. The Vehicles that enter in to the premises must be identified. Unclaimed / objects / su spicious persons / vehicles should not be allowed in the premises.
- 10. When asked, proper management should be made for keeping keys of rooms of the building. The security personnel shall also ensure that all the electrical equipment, instruments, light and fain, water taps are switched off during closure of the office or part of the office. Any irregularity is to be brought to the notice of the caretaker at once.
- 11. Proper Field Supervision has to be undertaken by the agency/Successful bidder.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
