1. 4. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) The penalty of Rs 1000/- per instance will be deducted from the billed amount for non-delivery or short delivery of milk on any particular day.
- 2) Milk has to be free of debris , sediments, off-flavours, abnormal colour/odour. In case of state /adulterated/post-expiry/substandard quality is delivered, the same shall be rejected and another supply thereof shall be made the same day by the bidder/supplier ,failing which, the local purchase will be done by the buyer itself and the excess amount, if any, so incurred by the bidder, will be deducted from the pending/incoming bills of the bidders/supplier in addition to the penalty.
- 3)The toned milk to be supplied in the hospital must be approved by FSSAI. Milk should be low in bacterial count, free of chemicals and of normal composition (Fat-3%, Non-fat milk solid - 8.5% including milk sugar and protein) and acidity (pH value of 6.6). The supplier has to submit QC report whenever asked for.
- 4) Payment will be made on the rates not beyond MRP and no transportation charges will be paid to the milk supplier. No advance payment will be considered.
- 5)Contact details should be provided by the bidder otherwise the bidder will be technical disqualified.
- 6)The successful bidder will have to sign contract agreement deed with the competent authority on a non-judicial stamp paper worth Rs100/- (Rupees Hundred only) and the expense on this account will be borne by the contractor.
- 7) The successful bidder must have an office in Delhi-NCR region.
- 8)The earnest money of unsuccessful bidders will be refunded without approval of any interest, in due course of time, after finalization of contract.
- 9)If the vendor wish to terminate the tender with the hospital between the contract period, the agency will have to give 03(three) month prior notice otherwise PBG will not be released and remaining dues will be recovered from the same.
- 10) The penalty clause may be levied when the supply of milk is stopped from the vendor side.

4. Generic

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
